WEBSITE TERMS OF USE

Acceptance of the Terms of Use

These Terms of Use are entered into by and between You and Iowa Hospital Association, an Iowa nonprofit organization ("IHA," "we," or "us"). The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, "Terms of Use"), govern your access to and use of the website, found at <https://www.iowahealthportal.org/terms-of-use.pdf> including any content, functionality and services offered on or through said website (the "Website"), whether as a guest or a registered user.

Please read the Terms of Use carefully before you start to use the Website. **By accessing and/or using the Website, you accept and agree to be bound and abide by these Terms of Use and our Privacy Policy, found at <https://www.iowahealthportal.org/privacy-policy.pdf>, incorporated herein by reference.** If you do not agree to these Terms of Use and Privacy Policy, you must not access or use the Website.

This Website is offered and available to users who are 13 years of age or older and reside or intend to reside in the State of Iowa who are interested in pursuing a career in healthcare. We may revise and update these Terms of Use from time to time in our sole discretion. All changes are effective immediately when we post them and apply to all access to and use of the Website thereafter. However, any changes to the dispute resolution provisions set forth in Governing Law and Jurisdiction will not apply to any disputes for which the parties have actual notice prior to the date the change is posted on the Website.

Your continued use of the Website following the posting of revised Terms of Use means that you accept and agree to the changes. You are expected to check this page from time to time so you are aware of any changes, as they are binding on you.
